- Three game minimum, 25 minute halves.
- Each division is divided into pools. Friday through Sunday morning consists of pool play with Sunday becoming a bracket of advancing teams to determine a champion within each division.
- All teams must be available to play Friday night at 6:00 pm.
- All teams must have a set of alternate numbered jerseys.
- Each team and player will be required to present valid USSF player passes. Unsanctioned teams can register with www.soccerCASA.com at or before the tournament for \$140 per team, (registration good for tournament only).
